LOCATION AND TIME:

- Park gates open at 10 AM. Competition and most attractions begin at 11 AM.
- The practice area will be located in Pavilion #5 (behind the Sky Rocket). All squads will have a scheduled practice and performance time and must be present as times will not be rescheduled. Performance area is matted, 36' X 42'.
- The competition will take place on the Lagoon Stage. All squads will be called in alphabetical order to perform. Performance area is matted, 36' X 42'.
- Please be flexible enough in your routine in case of any last minute changes. Alternate arrangements for practice area and competition may be made in the event of inclement weather.

REQUIREMENTS:

- A 2.5 minute or under competition routine, which should include segments in dance, transition, and cheer is required. If you are competing Cheer/Music your music portion must not exceed 1 minute and 45 seconds. Music may be broken up into smaller time frames. If you are competing All Music then the music portion must not exceed 2.5 minutes. You will be timed accordingly. There will be one point deducted for each second over the time limit.
- We ask that all squads perform in uniform.
- All squads must provide their own spotters as needed.
- Please provide a cassette tape or CD of your music and a back-up tape or CD. Please bring them with you when your squad is called to standby to perform. All squads **must** have a coach or representative present to play their music. There will be a Kennywood representative on-site to assist with the sound system.
- **NO REWRITEABLE CD'S (IPOD'S ARE ACCEPTABLE)**
- Any combination of dance steps, jumps, partner stunts, gymnastics or pyramids may be used as long as they meet requirement under the National Federation rules. Pom poms and signs may also be used.
- Judges will be provided from Champion Cheer Central.

ANY VIOLATION OF RULES WILL RESULT IN ELIMINATION FROM THE COMPETITION.

- The Awards Presentation will be held at approximately 2:00 PM on the Lagoon Stage following the conclusion of the competition.

- Trophies will be awarded to 2nd, 3rd, 4th, and 5th place squads in each division.
